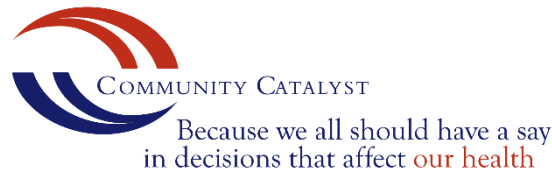

PTAC Collaborative

Mission, Purpose, and Cornerstone

- **Mission** – To strategically enhance the quantity and quality of community behavioral health and social service options through engagement in pre-arrest diversion
- **Purpose** – To provide national vision, leadership, advocacy, and education to facilitate the practice of pre-arrest diversion across the United States
- **Cornerstone** – PTAC is agnostic as to which model/brand of pre-arrest diversion is appropriate for a jurisdiction; each community must determine which approach solves its problem, fits the local situation, and can be addressed through current behavioral health capacity



PTAC Collaborative Five Strategic Areas

- **Big Idea/Big Tent** – the PTAC Collaborative leadership team
- **Think Tank** – for behavioral health (drug treatment, mental health) and social services to ensure their equal and critical seats at the table
- **Informing the Field** – for law enforcement and other justice system stakeholders focused on learning about developments in the field
- **Research** – for partners interested in developing standard metrics for police diversion research and evaluation
- **Community** – for residents and communities to add their voices and perspectives, and for practitioners already considering or implementing police diversion initiatives
